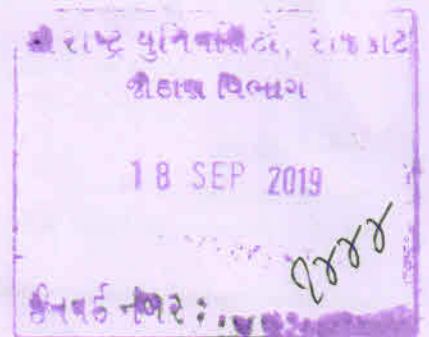

Sub: Counseling for State Quota seats for admission in ASU & H PG courses as per the time schedule circulated by the CCIM/CCH, New Delhi-Reg.

Sir/Madam,

I am directed to refer to subject cited above and to say that CCIM/CCH, New Delhi vide their letters dated 07.08.2019 and 08.08.2019 respectively, have circulated time schedule for completion of counseling and admission process for first year M.D./M.S. (Ayurveda/Siddha/Unani/Homoeopathy) for the academic year 2019-20. First Round of State quota seats Counseling for ASU & H PG courses was scheduled from 21<sup>st</sup> August, 2019 to 28<sup>th</sup> August, 2019. However, Ministry has received various representations from Candidates regarding delay in Counseling process at the level of various State Authorities. This is resulting in inconvenience to the Candidates for choosing their Post Graduate courses. Therefore, for benefits of Candidates and considering the future of these Candidates, State Government Authorities are once again requested to conduct State quota Counseling for ASU & H PG Courses at earliest.

2. Further, Candidates have also requested to conduct 02<sup>nd</sup> Round of all India quota PG counseling after completion of 01<sup>st</sup> Round of State Counseling. Therefore, for benefits of students, Counseling Schedule of ASU & H PG counseling is revised and 2<sup>nd</sup> round of all India quota Counseling is starting from 20.09.2019 (copy attached).
