



MEMORANDUM OF UNDERSTANDING

Between

Saurashtra University, Rajkot

And

Swarnim Gujarat Sports University, Gandhinagar

Saurashtra University, Rajkot represented by the Honorable Vice Chancellor Dr. Nitinkumar M. Pethani and Honorable Pro Vice Chancellor Dr. Vijay Deshani, acting under the charter, for one part, and the Swarnim Gujarat Sports University, Gandhinagar, Gujarat State, India represented by the Honorable Vice Chancellor Dr. Arjunsinh Rana, referred together herein as *<Parties>* settled a co-operational agreement (hereinafter *<Agreement>*) on the following basis:

Agreement contemplation:

Cooperation and promotion of further mutual interest of higher education, research and training in the fields of physical education, adventure sports, sports sciences and sports journalism & mass media technology.

Section I

Swarnim Gujarat Sports University, Gandhinagar, Gujarat State, India and Saurashtra University, Rajkot, mutually agree to cooperate in the following activities:

1. Co-operation in research activities and development projects in the fields of physical education, adventure sports, sports sciences and sports journalism & mass media technology;
2. Co-operation in the fields of education and training in the fields of physical education, adventure sports, sports sciences and sports journalism & mass media technology;
3. Exchange activities of students, faculty, researchers and staff members;
4. Organizing of scientific symposia, conferences and faculty/staff development programmes in the fields of physical education, adventure sports, sports sciences and sports journalism & mass media technology;
5. Organizing joint academic courses and programs in the fields of physical education, adventure sports, sports sciences and sports journalism & mass media technology;
6. Joint publications of scientific and educational research in the fields of physical education, adventure sports, sports sciences and sports journalism & mass media technology;

7. Other mutually agreeable undertakings.

Section 2

The fields and forms of co-operation will be identified separately and they will depend on the professional priorities and the financial resources of the institutions. Details of co-operation will be agreed upon in additional agreements to this *Agreement* in each case separately.

Additional agreements will contain the information on the concrete fields of co-operation, responsible coordinators, other organizational details, financial conditions etc. according to the principles of this *Agreement*.

Section 3

In connection, therewith *Parties* declare determination to implement the set of measures: law, organizational, economical, material and technical, informational and publicity, scientific and methodic, medical and biological and other measures according to the principles, subject matter, aim and objects of the cooperation.

Section 4

Prompt cooperation within the *Agreement*, exchange of information, harmonization of documents and actions will be done by administrative officials of the *Parties* within the framework of their areas of responsibility and by authorized representatives of the *Parties*.

Section 5

Any dispute arising in the course of collaboration, Parties will dispose by means of mutual negotiations. The *Agreement* is valid for one year from the date of signing this agreement and can be renewed for further periods by mutual agreement. The terms of the *Agreement* may be amended at any time by mutual written agreement of both *Parties*. This Agreement can be terminated by either party upon giving a three months' written notice. This Agreement is written in two copies having equal power for each of the two.
